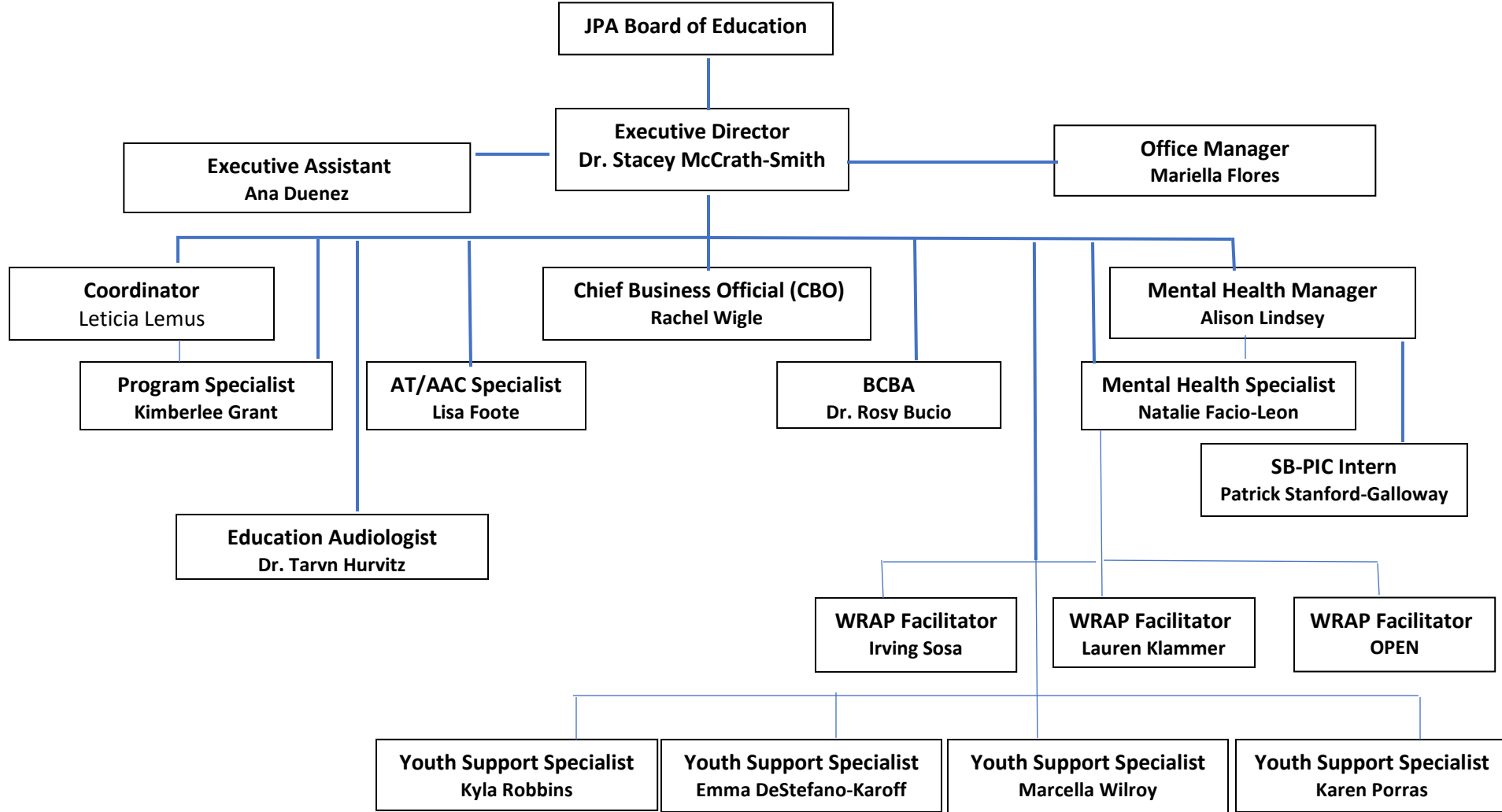




Santa Barbara County SELPA Organization Chart (2026-27)
